Thank you for being a past exhibitor at the Martin County Fair. We are looking forward to getting the 2025 fair setup and ready. We hope you plan to participate with us.

This year's fair is Aug 11th – Aug 17th, 2025. The Martin County Arena and Bank Midwest building will be open Tuesday 11 am- 9pm, Wednesday- Friday noon- 9pm, Saturday 10 am- 9pm and Sunday noon – 6pm. We require a \$50 deposit in addition to your booth rent to secure a spot. This deposit will be refunded Sunday at 6pm if your booth is **fully set up and you are present**.

You may set up your booth Saturday Aug 9th and Sunday Aug 10th from 8- 4pm. Monday the 11th 8am- 8pm and Tuesday morning 8am-10 am. All vehicles must be off the fairgrounds by 10:30am. **The fair opens at 11am Tuesday.**

Please fill out and sign the Application for Exhibit and the Minnesota ST19 form and return as soon as possible. Please make a copy of this contract and call if you have any questions. Contact Nate Amborn - ambornnathan@gmail.com or 507-236-2075 with any questions. NOTE your canceled check is your proof that you have an exhibitor's booth rented.

If you need a camping spot for the week please mark the application. Camping fee is \$210 for the week. A season pass is required for each person camping. You must pay in advance for camping. One season pass is given per booth.

Smoking is prohibited in all buildings on the fairgrounds Any property that is not removed within thirty days will become property of the Martin County Fair Sale of Fireworks including Class C, Cigarette lighters, Knives (except household types) or any offensive material is prohibited on the Fairgrounds. Any booth or exhibit doing so will be immediately closed, removed from the fairgrounds, and will not be permitted to return in future years. No refund will be given. Lessee covenants to indemnify and save harmless lesser for and against any and all liability, arising from injury during the term of this event to person or property, occasioned wholly by or in part any act or admission of lessee, guest, employee, assigns or sub-lessees of lessee.

PENALTY — Operators who do not have Form ST19 or a similar written document from sellers can be fined a penalty of \$100 for each seller that is not in compliance for each day of the selling event.

Information for Sellers and Event Operators

Operators/organizers of craft, antique, coin, stamp or comic book shows; flea markets; convention exhibit areas; or similar events are required by Minnesota law to get written evidence that persons who do business at the show or event have a valid Minnesota tax ID number.

If a seller is not required to have a Minnesota tax ID number, the seller must give the operator a written statement that items offered for sale are not subject to sales tax.

All operators (including operators of community sponsored events and nonprofit organizations) must obtain written evidence from sellers.

Certain individual sellers are not required to register to collect sales tax if they qualify for the isolated and occasional sales exemption. To qualify, all the following conditions must be met:

- The seller participates in only one event per calendar year that lasts no more than three days;
- The seller makes sales of \$500 or less during the calendar year; and
- The seller provides a written statement to that effect, and includes the seller's name, address and telephone number.

This isolated and occasional sales provision applies to individuals only. It does not apply to businesses.
